The province adopted the vision that by 2020, Bataan will have the lowest poverty incidence resulting from quality growth attaining top level human development index in the Philippines. Abet returned to Congress and was appointed as member of the influential Commission on Appointments (CA). Armed with decades of public service, Congressman Garcia seeks to push for meaningful legislation that will benefit not only Bataenos, but every Filipino as well.
